1.	Promoter	The competition promoter is Fibrus Ltd (Company number NI655901) of 108-113 Dargan Crescent, Belfast, Northern Ireland, BT3 9JP.
2.	How to enter	<p>To enter the promotion, go to our website at https://fibrus.com/ and follow the instructions on the homepage to complete your entry.</p> <p>https://fibrus.com/home-for-christmas</p> <p>You may only submit one entry to this promotion. Any additional entries will be void and will not be entered into this promotion.</p> <p>By submitting your entry, you confirm that you have read and understood these terms and conditions and agree to be bound by them.</p>
3.	Start date	This promotion will start at 09:00 on 05/11/24.
4.	Closing date	<p>The closing date for entries to this promotion is 00:00 on 20/11/2024. Entries received by us after this time will be void and will not be entered into this promotion.</p> <p>Judging will take place as soon as possible after the closing date.</p>
5.	Eligibility	<p>The promotion is free to enter and is open to residents of Northern Ireland and Cumbria who live in areas connectable to Fibrus broadband and are over 18 at time of entry.</p> <p>The following persons are not eligible to enter:</p> <ul style="list-style-type: none"> • our employees or workers, or the employees or workers of any company in our group; • employees or workers of any organisation involved in the operation or administration of this promotion; and • members of their immediate families. <p>Entries will be void if they:</p> <ul style="list-style-type: none"> • do not comply with these terms and conditions; or • are incomplete or unclear; or • are considered by us to be part of an attempt to manipulate or unfairly influence the outcome of this promotion. <p>We may ask for proof of age, residence or eligibility. The Prize	<p>There is one prize for the Cumbria region, and one for the Northern Ireland region: return Christmas 2024 flights home (up to a maximum value of £2,000) from anywhere in the world flying into Belfast International (BFS), Belfast City (BHD) or Dublin (DUB) (for Northern Ireland bound travelers), and an airport within a 2.5 hour driving distance of Cumbria, including Manchester, Glasgow or Newcastle (for Cumbria bound travelers).</p> <p>On your entry form, simply nominate who you want to bring home for Christmas, where they are in the world and why you would love to see them home for Christmas. Please make sure you also tell them about the promotion.</p> <p>One winner will be selected for Cumbria and one for Northern Ireland.</p>

Selection of winner	<p>The winner of this promotion will be the entry chosen by a panel of Fibrus judges including one independent member to be the most deserving and detailed application based on a marking matrix out of all entries correctly submitted in accordance with these terms and conditions.</p> <p>The names of the judges are available on request.</p> <p>The decision of the judges will be made between 21/11/24 and 29/11/24 (latest) and is final.</p>

Contacting the winner	<p>We will notify the winner as soon as possible on or after the date of judging, using the contact details provided in the entry.</p> <p>Reasonable efforts will be made to make contact the winner/nominated person(s) over a period of 48 hours. If it has not been possible to contact the winner and the nominated person(s) in that time, the prize will be forfeited and awarded to a reserve winner selected by the judges.</p>
9.	Receiving the prize	<p>We will co-ordinate booking the return Christmas flights, in agreement with the winner/nominated person. The inbound flight must arrive in the eligible airport on or prior to the 20th December 2024. We will cover the cost of the flights up to an aggregate maximum value of £2,000. Any costs over this amount must be met by the winner/nominated person at or before the booking is completed.</p> <p>We may, at our sole discretion, cover the cost of the nominated person's pre-booked travel.</p>
10.	Publicity and use of personal information	<p>Please note that the winner and the nominated person's personal information will be used to process the entry, to contact the winner and nominated person and to book the flights and to publicise this promotion.
