

Fibrus 2025 Christmas Classroom - Free Prize Christmas Competition

NI Primary Schools P1 & P2 classes (or equivalent)

Terms & Conditions

1.	The Prize	There is one prize available. The prize is a festive classroom experience delivered by the Fibrus Tinsel Team (Santa's Elves). The experience will include: • A special visit from the Fibrus Tinsel Team (Santa's Elves). • A pre-recorded message from Santa. • A gift for each pupil in the winning class(es) (up to a maximum value of £2,000 for all prizes within the class). The school visit will take place on either Monday 8 December 2025 or Tuesday 9 December 2025, and the winning school must be available on one of these dates. It is not possible to change these dates.
2.	Eligibility	The competition is free to enter and is open to all NI primary schools (or equivalent). Your school can nominate its P1, P2, or P1/P2 composite classes (Foundation Stage) class(es) (or equivalent). Our employees, or employees of our related companies and suppliers (and their immediate families) or any other person professionally connected with the competition are ineligible to enter the competition. Entries will be void if they: • do not comply with these terms and conditions; or • are incomplete. Our decision as to whether a school (or its entry) is eligible for this competition is final and we are not obliged to provide any reasons for disqualification.
3.	How to enter	To enter the competition, go to our website at www.fibrus.com/christmasclassroom and follow the instructions to complete nomination entry form. There is a limit of one entry per school to the competition. Year 1 and Year 2 class nominations should be included on a single entry. Excess entries will be void. By submitting your entry, you confirm that the school has read and understood these terms & conditions and agrees to be bound by them. Entries that do not comply with the competition rules will be void and will be ineligible to receive the prize.
4.	Dates for the competition	The competition will start on Wednesday 19 November 2025. The closing date for entries to this competition is noon on Wednesday 26 November 2025. Entries received by us after this time (whether or not they were sent before) will be void and will not be entered into this competition. Judging will take place as soon as possible after the closing date.
5.	Selection of Winner	The winner of the prize will be the entry considered by a panel of [3] Fibrus judges, including one independent member, to be the most deserving nomination, based on judging criteria applied to all entries correctly submitted in accordance with these terms & conditions. The names of the judges are available on request. The decision of the judges will be made by 28 November 2025 and is final.
6.	Contacting the winner	We will use all reasonable efforts to contact the winning school over a reasonable period of time not exceeding 72 hours on or after the date of judging, using the nominated contact details provided in the entry.

		If it has not been possible to contact the winning school in that time and/or if the winning school is unable to accommodate the school visit on either of the dates stated above, the prize will be forfeited and awarded to a reserve winner selected by the judges.
7.	Receiving the prize	We will liaise directly with the winning school to confirm timing and access arrangements for the school visit. To receive and display the pre-recorded message from Santa, the school must have suitable access to a screen or device capable of playing the video file. We will provide the winning school with a general wish list for the children to select some gifts they would love to receive. This must be completed and returned to us no later than by 12 noon on Wednesday 3 December 2025.
8.	Publicity and use of personal information	Any personal information submitted as part of an entry will be used to process the entry, to contact the winning school, and to facilitate the delivery of the prize. To receive the prize, the winning school and its representatives must consent to reasonable participation in publicity for this competition, the prize, and Fibrus. This means that we may use all names, images, descriptions, photographs, video footage, and other information submitted in connection with the competition or prize, in any media, without payment and without time restriction. We may also film, record, or photograph the visit and prize delivery. All films, recordings, and photographs will be owned by us and may be used publicly and/or for promotional purposes.
9.	Filming and consent	We will record video and photography during the prize visit for use in publicity and promotional materials. It is the responsibility of the winning school to ensure that the appropriate photography and filming consents have been obtained from parents or guardians of all participating children prior to filming. We will help, as needed. If there are pupils in the class who do not have permission to be filmed, they may still participate in the experience, but we must be made aware of this in advance of the visit.
10.	Ownership and use of entries	The winning school will retain ownership of any intellectual property rights (including copyright) in its entry but agrees to grant us a licence to use it for any purpose connected to this competition. The licence includes the right for us to: edit or modify the entry (including resizing, adjusting the colour, or adding elements such as text), adapt it or incorporate it into other materials; sub-licence it to third parties or companies within the Fibrus group to use for the purposes described above; and republish it (or any version modified in the way described above) on any media anywhere in the world. The winner is not entitled to any fees for granting this licence and may not terminate it unless agreed in writing by Fibrus.
11.	Our liability	While nothing in these terms and conditions will limit our liability for death or personal injury caused by our negligence or for fraud, we will not be legally responsible to entrants or winners for any losses that were not foreseeable to us or to you at the time of entry to this promotion or which are caused by a third party. Our liability under or in connection with the competition or these terms and conditions shall be limited to the amount of the prize.
